Option B: Business Portfolio "Sweep"

- Develop opportunity portfolio
- Compare projects based on expected value, risk/reward, productivity and other factors
- Deliverable: Portfolio of selected opportunities



Develop System Requirements

- Develop software requirements based on findings from steps 1 and 2
- Develop organizational process flow
- Deliverable: Evaluation plan



Deploy Pilot System

- Configure software
- Provide access to hosted "in the cloud" software
- Fine tune system based on feedback and learning
- Deliverables: live system accessible by client users; refined system requirements


Roll Out Production System
